The meeting aims to promote the discussion around the functioning of markets and their regulations, that is relevant for Latin American and Caribbean Economies. This includes papers addressing issues in other regions when those issues are deemed relevant for the regional context.

We welcome both theoretical and empirical contributions in any topic within the field of Industrial Organization, including (but not restricted to) determinants of market competition and of pricing decisions, productivity, innovation, investment, auctions, market and mechanism design, effects of public policies such as antitrust law and government regulation, and both theoretical and empirical approaches to specific themes such as education markets, energy and the environment, financial markets and health care markets.

Participants to any workshop are welcome and encouraged to attend the other workshops.

Paper Submission

Full papers, written in English, must be submitted for consideration for the meeting. The cover page should include: the title of the paper, institutional affiliation, including address, phone, and email of each author and an abstract with the appropriate JEL classification.
